1.7	AND PREKINDERGARTEN.
1.8	Subdivision 1. Disciplinary dismissals prohibited. A pupil enrolled in a preschool or
1.9	prekindergarten program, including a child participating in early childhood family education,
1.10	school readiness, school readiness plus, voluntary prekindergarten, Head Start, or other
1.11	school-based preschool or prekindergarten program may not be subject to dismissals under
1.12	this chapter. Notwithstanding the language in this subdivision, expulsions and exclusions
